We teach children, teenagers and adults to sail through our non-profit Miami Yacht Club, Youth Sailing Foundation. A non-profit company controlled by the Miami Yacht Club. It also runs our adult sailing and Regattas. These classes and races are open to everyone - not just members of the Club.

We provide meeting space to many local, national and international organizations including the Emerald Society, the United States Coast Guard Auxiliary, the Multihull Association of South Florida, and others.

We also host the City of Miami Marine Patrol and Underwater Recovery Unit.

We are always interested in new members who share an interest in boating, sailing and angling. Our club offers year-round activities from our famous Miami to Key Largo Race to other sailing and water events and classes.

Our social calendar offers lively activities for all ages.

Our burgee is recognized around the world and allows our members reciprocity privileges in many other yacht clubs.

The bar is open from Tuesday through Sunday; from 11:00 am till close' kitchen hours are from 11:00 to 20:30 hours Sunday through Wednesday and until 22:00 hours Thursday through Saturday The bar and kitchen are closed on Monday.

The management office is open from 10:00 to 18:00 hours Monday to Friday.

MEMBERSHIPS

There are 5 categories of memberships available.

All members receive a member discount of 10% on all food and beverage off our menu prices.

Members pay a half-fee room or area charge for private parties in our facilities, and 10% off food, beverage, serving staff charges, set up and cleaning fees for their events. All member events are on a first come basis of availability. All members have free use of the conference room if not occupied by a scheduled private or business event.

All members are required to have a personal/professional background check. All initiation fees are on a one time.

FULL

Allows full voting rights on all matters concerning club activities, acceptance of new members and full use of all facilities.

Only Full members are allowed to lease 1 (one) wet or dry slip upon availability. This includes 1 (one) parking space for their cars when their boats are out to sea for the period. All other parking is daily with no overnight parking unless approved by management.

New full members are considered associate members until voted in as full members after a period of 6 months.

Initiation fee of \$2800; monthly dues \$219.19 which includes \$75 of food and beverage credit at the Latitude Bar and Restaurant

SPOUSAL

A spousal member must be the spouse of a full member. It allows full voting privileges and the right to dry or wet boat storage.

There is no initiation fee. Monthly dues are \$106.35 which includes \$75 F&B credits.

JUNIOR

They are children that are sponsored or of members under 21 years of age. Once of age, if they choose to become a member, there is no initiation fee.

Annual fee of \$60.24

NON-RESIDENT

For residents that live 100 miles from Miami-Dade County and only plan to use the club for a maximum of 4 months a year. They have no voting privileges. If used over 4 months non-residents are asked to become full or social members.

Initiation fee \$1400; monthly dues \$76.48 with no of F&B Credits

SOCIAL

Has full use of our facilities but no voting, dry or wet storage rights.

Initiation fee \$250; monthly dues \$151.48 including \$75 of F&B Credits
